Owensboro Parks & Recreation Scholarship Program General Information

The program is designed to aid those persons in our community who are in need of financial assistance in order to participate in our recreation programs. The Owensboro Parks & Recreation Department feels it is essential to every child's development to interact with other children. Approval of a participant's application for scholarship allows for partial cost of program participation to be paid through our scholarship fund.

Not to exceed \$500 per family member per year.

To receive consideration for a scholarship award, it is important to adhere to the following steps.

1. Applicant **MUST** be a resident of Daviess County, Kentucky. Must be 18 years or younger/or disabled.
2. Obtain and complete an application from the Owensboro Parks & Recreation Department.
3. **MUST** attach most recent Federal Income Tax Return or proof of household income (pay stub, Social Security statement or child support statement), also, if applicable, include approved form for free/reduced lunches, approved form for food stamps, or public-housing verification.
4. Send application, **program registration**, and accompanying documentation to:

Applications may be dropped off at the Parks Office, 1530 McJohnson Avenue, Monday through Friday, 7:30 a.m. – 4:30 p.m.

5. Applications must be submitted to the Parks & Recreation office **10 days prior to the program's registration deadline**. Failure to submit the application in time may result in the application being denied. Applications received fewer than 10 days before the registration deadline, must pay the full fee for the program. Upon approval of a scholarship, the difference will be refunded in the form of a check from the City of Owensboro. You should receive the refund check about 2 weeks after notification.
6. Applicants will be notified of the status of the scholarship. In order to participate in the program, approved applicants must pay in full the remaining portion of the program fee on or before the registration deadline.
7. Scholarship participants must have regular attendance or risk the chance of losing the scholarship (up to the discretion of the Program Administrator).
8. Each Day Camp participants must pay the yearly registration fee in full. Only weekly fees are eligible for scholarship funds.
